We purchase and maintain excellent rental equipment for your child's use. It is set by trained personnel based on manufacturers' recommendations for their weight and ability. Regardless of our diligent efforts in care and proper adjustments of this equipment, injury is possible. Therefore, it is necessary that you read and understand the following statement: I recognize that any binding may not release under certain falls and recognize that there is an inherent danger in the use of any ski equipment. I agree to hold Cataloochee Ski Area, and Cataloochee Ski & Ride Center, and any employee thereof, harmless and blameless because of any accident of injury that my child may sustain while using the equipment or participating in the CAT Trackers program. ***I agree to the stipulation that if my child cannot cooperate with the ski instructor and due to excessive crying or fatigue must be returned to me, I will forfeit all monies paid.*** At times ski instructors, supervisors, and or the news media will photograph or film classes in progress. This will serve as a release to use the photos or film for promotional information purposes.
